3) IPSC Executive Council reports

IPSC President Mr. Vitaly Kryuchin,

Dear Regional Directors,

Dear Delegates,

Dear Guests,

On your tables you can see a written report of what has been done by our team.

First of all, I would like to thank all of you for coming and for your contribution to the IPSC development.

We are growing, new Regions are joining us. Each Region who is sitting here is completely independent. We are big democratic widely developed shooting sport. We are a worldwide Sports movement!

We have fantastic matches. Thanks to the Thai Region for hosting this great Handgun World Shoot at the new range. It is a very good place to invite Olympic officials to present our sport.

Our Rules Committee has been working very hard during the last years. We should pay respect to their work. We were a bit late distributing the proposed Rules amendments and we received some complaints about the amendments. I offer to discuss the Rules and to postpone the final decisions to the online Extraordinary General Assembly at the end of March to have enough time to discuss the Rules.

Going back to the matches, I would like to tell you that during the pandemics many sport federations had to stop their activities: no matches, no trainings, nothing. But we kept having hundreds of matches, even during the pandemic years. Opposite to the Olympic shooting which we all respect and majority of us came from this sport, where athletes are paid to take part in competitions and to train, our athletes spend their own resources to train, to participate in the matches. Olympic sport which we all respect is like a garden with a good gardener to take care about it. We are, sorry to say that, like jungles, we are growing naturally and you cannot stop it, we are movement as Olympic movement. We just need the forester.

Our membership as I told you is also growing.

When I started IPSC I saw fantastic matches, fantastic Range Officers working hard at the range, fantastic administration. I wondered how it is possible to have no Instructors or Trainers, there was no unified system to teach athletes. I promised to put my effort to organize instructors' organization. Starting from 2018 we conducted over 30 Seminars. We built educational standard of the IPSC teaching. We taught hundreds of Instructors and Trainers and recognized them. Now as we got GAISF recognition, we are one step from getting an Olympic recognition. We sat together with Alexander Milyukov, Dino Evangelinos, Sasja Barentsen, Olga Kuznetsova and started to think how to build this Association and we built the Association from zero. We even created a term "Gun Handling Culture". It is very crucial that our athletes are safe. Now we have certified Instructors, we are building a platform connecting it to the ESS and IPSC web page. Now many top athletes joined our team: Eduardo de Cobos, Alex Esteve, Raine Peltokoski and many others. I would like to emphasize that MISIA is a part of IPSC, MISIA belongs to IPSC! And our mission is to develop Gun Handling Culture. Big Regions who have their own good Athletes education programs might not need MISIA but new Region need it! If you trust, please give me a chance to finish this work. If you have any doubts or suspicions, please come to me and we will discuss it. We have democracy.

As for the administrative work. We discuss everything at the Executive Council and Continental Council meetings and makes decisions together as a team. Our financial reports are very clear and transparent. IPSC Treasurer, Mr Roland Dahlman is an honest man, he always tells that if you have any questions, you can come to him and ask any question and he will answer and show you everything. We have nothing to hide. Friedrich Gepperth, you know him for many years, if he feels that something is wrong, he will never keep silent. Dino Evangelinos, you know him, if you call him at 7.00, if you want to meet him in the evening, go to the range. Alain Joly who contributes a lot to the IPSC, he works hard to bring Sponsors to the IPSC. Jose Carlos Belino, he changed the IPSC world with the Electronic Scoring System and he asks only 17,000 USD for this. Do you know how much other developers asked? 150,000 USD was a minimum price. When I found it out, I immediately signed the contract with Jose. Jose Carlos Belino works hard for IPSC. Jürgen Tegge, who works hard sanctioning matches and works with the Sanctioning Committee, recruit new members when needed. Olga Kuznetsova who works every day from morning till night, always answers you, always works for you. She works all week including Saturday and Sunday sometimes. We have online meetings every day. Executive Council meets every month and we find common decisions and solution working as a team. Nikki, who protects IPSC logo, who works with Partners, new program, by the way. We have several new Partners.

There were some questions to the budget, the Treasurer will give a report about it. There were questions about spending on MISIA. That was spent to cover MISIA Instructors travels and accommodation during the Seminars. We need Instructor and Trainer Association for getting Olympic recognition. What critique I hear? That IPSC President put all his efforts to MISIA and forgot IROA. But we never forgot them and now we found a way how to change it. Main problem is that IROA, diamonds of IPSC, are volunteers and even travel expenses are not covered for them to full extend. In Olympic disciplines all the expenses are covered. Our Range Officers work very hard and their travel expenses are not covered. Not anymore! We with IROA President promise that all these volunteers will come to work and will have their tickets paid!
